Passport holders of Italy visa-exempt countries are allowed to remain in Italy and the other Schengen countries for up to 90 days, within a six-month period. Nationals of Australia, Israel, Japan, Canada, New Zealand, Republic of South Korea, the United States of America that wish to stay longer in Italy need to obtain a residence permit at the relevant Italian authorities, within three months of arrival in Italy.

The Schengen visa is the most common visa for Europe. It enables its holder to enter, freely travel within, and leave the Schengen zone from any of the Schengen member countries.

Holder of a Uniform Schengen Visa can travel to these countries: Austria, Belgium, the Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, the Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, and Switzerland.

An Italy Schengen visa allows the holder to travel to any country within the Schengen area and remain there for a maximum of 90 days within a six month period. Since Italy is part of the Schengen area, you can enter Italy with a Schengen visa as well. For stays that are longer than 90 days, you have to apply for an Italy National visa instead.

Tourist visa Original, signed passport: Passport must have at least 2 blank pages for visa purposes, must be valid for at least 90 days beyond the return date of the trip to the Schengen Area and has to be issued within the last 10 years on the day of leaving the Schengen Area.

The visa policy of the Schengen Area is set by the European Union and applies to the Schengen Area and to other EU member states except Ireland. The visa policy allows nationals of certain countries to enter the Schengen Area via air, land or sea without a visa for stays of up to 90 days within a 180-day period.
